

Vector Minimization Workshop

Adopting a proactive approach to minimizing vectors is cost effective and reduces the risk to public health

The Southern California Vector Control Environmental Taskforce is hosting a free technical workshop to address planning, design, and maintenance considerations related to the potential for vector production in a variety of land uses. Vectors (i.e., mosquitoes, rats, flies, ticks, and fleas) transmit diseases harmful to humans. Proper planning can largely avoid or eliminate vector problems and reduce liability. Vector minimization principles associated with structural stormwater BMPs, constructed wetlands, water management, and landscape design will be emphasized.
